Installation

To use the FLTCON-2-24VDC with your desk, make sure to also acquire the PA-BT1-24-2200 and connect them together using the diagram below. More information about the PA-BT1-24-2200 can be found at the link <u>here</u>.

- 1. Insert the battery into the dock. Determine the desired placement of the dock on the underside of the tabletop.
- 2. Remove the battery from the dock and attach the battery dock to the underside of the tabletop using the included hardware.
- 3. Connect the dock wiring to the control box. For a mobile desk, the new FLTCON-2-24VDC control box will replace the existing one on the purchased unit.

NOTE: Battery must be fully charged prior to the first use.

NOTE: To make your standing desk fully mobile, we recommend installing caster wheels.



Operational Procedure

To raise the desk, press and hold the UP button. To lower the desk, press and hold the DOWN button. The UP and DOWN buttons are momentary controlled. When either directional buttons are released, the desk will stop immediately.

To save a position, move the desk to the desired height. Press the "M" button followed by a number. The LED display will flash an 'S', followed by an 'S - Number'. This will indicate that the position has been saved. To use a preset, press any of the numbered buttons and the desk will begin to move to the preset position. It is important to ensure that no obstacles impede the motion of travel. To stop motion while in travel, press any button. If the desk does not function as intended or the LED display flashes "RST", please follow the Reset Procedure outlined below.

Reset Procedure

To enter the Reset Procedure, press and hold the DOWN button on the Hand Remote until the LED shows "RST" (If you are not using an LED hand remote, hold the DOWN button for about 10 seconds). Release the DOWN button. Press and hold the DOWN button once more until the desk(s) lower completely then slightly rise before coming to a stop. This signals the end of the reset procedure. Release the DOWN button and your system is now ready to use.

*If the height difference between the legs exceeds 1.5 inches, stop the reset procedure & contact us. *If the handset displays 'HOT', let the unit cool down for 20 minutes before starting the reset procedure again.

Setting Upper & Lower Limits

Upper Limit

- 1. To set the upper limit, use the UP/DOWN buttons to move the table desk to your desired maximum height position.
- 2. Once it is at the desired position, press and release the "M" button so it shows "S-".
- 3. While "S-" is shown in the display, press and release the up arrow once.
- 4. Hold the "M" button until the display shows "999" then release.

The display will then automatically revert back to the height display. The upper limit is now set.

Lower Limit

- 1. To set the upper limit, use the UP/DOWN buttons to move the table desk to your desired minimum height position.
- 2. Once it is at the desired position, press and release the "M" button so it shows "S-".
- 3. While "S-" is shown in the display, press and release the down arrow once.
- 4. Hold the "M" button until the display shows "000" then release.

The display will then automatically revert back to the height display. The upper limit is now set.

Removing Limits

- 1. Press and release the "M" button so it shows "S-".
- 2. While "S-" is shown on the display, press and hold "M" again until the display shows "555"

The display will then automatically revert back to the height display. Any previously set limits are now removed.

*After the upper and lower limits are set, the previous memory positions (1,2,3,4) may be outside the new range of movement. If this happens, simply reset the memory positions.

*A Reset procedure requires the desk base to fully retract beyond any lower limit. Please ensure you have proper clearance below the desk base.

*If you attempt to revise a previously set upper or lower limit and it is outside of the existing range, you will need to remove the original upper/lower limits first.

Troubleshooting

Troubleshooting Guide				
Problem	Description	Solution		
Remote LED is off.	Low power mode activated	Press any button on the remote and LED will activate.		
	Connection issue	Disconnect and reconnect the RJ-45 remote connector. Ensure connection is secure and cable is not damaged.		
Lifting columns do not move when motion control buttons are pressed.	Limit switch reached	Follow "Setting Limit Switches" instructions to remove the programmed limit (FLTCON-02 only). If maximum or minimum height limit has been reached, please move the system in the opposite direction.		
	Connection issue	Disconnect and reconnect the Lifting Columns, Control Box, AC Power, and Remote.		
Lifting columns travel at a significantly slower speed than rated specification.	Weight issue	Ensure weight capacity has not exceeded the maximum load rating.		
Unusual noise during travel.	Weight issue	Ensure weight capacity has not exceeded the maximum load rating.		
Lifting columns stop abruptly during travel.	Obstacle	Ensure there are no obstacles in the path of the lifting columns. If the movement continues to fail, initiate the Reset Procedure.		
Lifting columns are not level.	Out of sync	Disconnect and reconnect all cables (Lifting Column, Control Box, AC Power, and Remote), then initiate the Reset Procedure.		

Error Codes (remotes with LED display)			
Code	Description	Solution	
E01	M1 overcurrent protection	All columns stop moving and remote displays E01-E04. Ensure that the total	
E02	M2 overcurrent protection	weight capacity of the lifting columns has not been exceeded and that no obstacles obstruct the movement. Press any key and remote will display RST.	
E03	M3 overcurrent protection	initiate the Reset Procedure. If the issue persists, disconnect and reconnect all of the lifting columns, including the main power. Repeat the Reset Procedure	
E04	M4 overcurrent protection		
E07	M1 hall error	All columns stop moving and remote displays E07-E10. Ensure that all columns	
E08	M2 hall error	are still properly connected to the control box. Check to see if any cables have	
E09	M3 hall error	Procedure. If the issue persists, disconnect and reconnect all of the lifting	
E10	M4 hall error	columns, including the main power. Repeat the Reset Procedure.	
H01	Over heat / Duty Cycle protection	All columns stop moving, remote displays H01 (if LED screen available). Allow the system to rest for 16 minutes, use normally. Follow the Duty Cycle rating to ensure no issues arise from overheating.
